CALL TO ORDER/ROLL CALL

Due to the appellant (Mr. John Furneaux) participating in the hearing via conference call, Commissioners introduced themselves during the roll call. Eight Commissioners were present, three were absent.

1. **GENERAL BUSINESS**

- 1.1 Presentation regarding the Hearing Procedures for Airport Commission Administrative Citation Appeals.
 - Mr. Mitchell gave a PowerPoint presentation overview of the hearing procedures for curfew administrative citations.
- 1.2 Conduct a hearing on appeal of the decision of the Director of Aviation of the Norman Y. Mineta San Jose International Airport to Issue Administrative Citation No. 2016-33-2921 – Eastern Air Lines Group, Inc.

Bob Lockhart, Deputy Director of Operations, Michael Glazer, Airport Operations Superintendent and John Furneaux, Vice President for Flight Operation for Eastern Airlines, were sworn in by Mr. Mitchell prior to their testimony.

Mr. Glazer presented staff testimony on the reason for the administrative citation. Staff conceded that Eastern Air Lines Group, Inc. had articulated facts supporting a Force Majeure Event exemption pursuant to San Jose Municipal Code Section 25.03.320 A. Staff agreed that aircraft operations for Eastern were delayed due to an unforeseen mechanical problems that delayed an aircraft operation that had been scheduled prior to the curfew hours, San Jose Municipal Code Section 25.03.245 A.

Appellant Mr. John Furneaux, Eastern Air Lines Group, Inc., presented testimony on why the citation should be canceled. Mr. Furneaux explained that Eastern only has five (5) aircraft, and that two (2) of the aircraft were grounded for unforeseen mechanical difficulties thereby causing the flight originating in Havana, Cuba to be delayed in arriving at San Jose Airport. A spare plane had to be ferried from Boston to Miami, plus a crew change, and then flown to Havana, Cuba to pick up the passengers. There were no hotel accommodations available for the passengers in Havana and they could not spend the night at the airport in Havana.

Both presentations were followed by questions from the Commissioners.

A vote was taken to either uphold or cancel the citation.

Action: A motion was made to cancel the citation.
