The Airport Commission meetings are subject to the Brown Act, a California law governing public meetings and the City of San Jose Consolidated Open Government and Ethics Provisions (City Resolution No. 77135). Under the Brown Act, the members of the Airport Commission may <u>not</u> address or discuss matters unless such matters <u>are listed</u> on the agenda and properly noticed.

If you wish to address the Commission on an item which <u>is</u> listed on the agenda, you may be heard at the time the item is discussed by the Commission by filling out a Request to Speak card and submitting it to the Commission secretary.
