No action required. 11/14/16 – Commission briefed on south flow operations and the complaints from Sunnyvale residents regarding the noise impacts. The Commission also heard public comments from Sunnyvale residents. The Commission unanimously adopted a motion asking staff to write to the FAA to request the FAA to take actions to reduce the noise impacts of south flow operations (adopted on a an 11-0 vote). 2/27/17 – Staff provided a follow up report on the FAA’s response to the letter prepared by staff on the noise impacts of the south flow operations. Attending members of the community requested the Airport establish a roundtable forum, to include the FAA, to address the noise impacts of south flow operations. The Commission adopted a unanimously motion to recommend the creation of a noise roundtable to address the south flow issue (adopted on a 7-0 vote).
